Three benches are now ready to be painted by the Community Payback Team. Cllr Mowbray will deliver the paint on Saturday. **SM**

119/24 To discuss any matters arising from the minutes of the previous meeting that are not elsewhere on the Agenda.

058/23 i) Bus Shelter – the application for funding from the National Lottery was unsuccessful. It was deemed not to be a ‘community based project’. Cllr Mowbray will pursue this decision. **SM**
Cllr Needham suggested that there may be available Do It For East Yorkshire funding in September. It may also be possible to apply to the Police and Crime Commissioner’s Roads and Safety Fund.

068/23 i) Emergency Box – a date for a ‘dummy’ run to be arranged - outstanding.

020/24 i) Drainage – Cllr Flanagan has identified areas where there is narrowing in the pipes. The Parish Council will approach ERYC about having a survey of the drains carried out. **YE**
A quote of £2k has been received for a cctv survey and jetting. Another quote will be sourced.
Cllr Mowbray will contact the owners of Herdborough House with regard to clearing the gullies. **SM**

091/24 i) Event – 5th November – Cllr Mowbray has contacted Ardent Fireworks for a new quote.
Enquiries are continuing into the using of the field behind the Village Hall for the fireworks.

120/24 Agenda items:

i) Casual Vacancy – there is still a vacancy for a Parish Councillor.

ii) Model Financial Regulations 2024 – this will be deferred to next month.

121/24 Road Safety:

i) Road Safety issues at the school – there has not been any response from ERYC Traffic Management. The 20mph rondels on the road are on the list to be repainted. Cllr Needham will check how far up the schedule the work is. **DN**
Enquiries will be made into extending the 20mph zone near the school. **DMi**

ii) HGVs in Elvington and Sutton upon Derwent – there is not any further update.

iii) Speeding – Speed Indicator Devices (SIDs) – it would be possible to claim for 2no. SIDs to be used across 4 locations. Cllr Patient will circulate a map of the proposed locations. A grant may be available from the Police and Crime Commissioner **AP**
